



What is CEA CAPA Secure?

Your program advisors at CEA CAPA recommend that you make our **CEA CAPA Secure** plan a key part of your abroad program planning. Under this special protection plan, you may withdraw from your program for any covered reason up to one calendar week before your program's start date. **CEA CAPA Secure** provides prorated refunds for these covered circumstances:

- Medical Incident that results in serious injury, illness, or death to participant or immediate family member.
- Significant injury that limits mobility (i.e. leg, foot, hip, back)
- Death in immediate family
- Diagnosis of terminal illness
- Destruction of Primary Residence

What is refundable prior to departure?

A refund includes all *recoverable* program fees that you have paid to CEA CAPA based on the time of your cancellation, less the \$95 application fee, non-refundable program confirmation fee, and the cost of the **CEA CAPA Secure** plan.

Am I eligible for any kind of refund after my program starts?

Yes, CEA CAPA Secure covers trip interruption refunds after your program has started under the following conditions:

- Medical Incident that results in serious injury, illness, or death to participant or immediate family member.
- Significant injury that limits mobility (i.e. leg, foot, hip, back)
- Death in immediate family
- Diagnosis of terminal illness
- Destruction of Primary Residence

How are trip Interruption Refunds determined?

Refunds are prorated based on the recoverable costs associated with how far along you are in your program when a covered condition happens. As with a pre-program start refund, your \$95 application fee, non-refundable confirmation fee, any late fee, and the cost of **CEA CAPA Secure** are not refundable.

How much will CEA CAPA Secure cost me?

The cost of the CEA CAPA Secure plan is based on the type of program that you have selected. Our pricing is as follows:

- A fee of \$475 for semester and trimester programs
- A fee of \$275 for summer and short-term programs
- A fee of \$1,000 for academic year programs

How do I enroll in CEA CAPA Secure?

We make it easy for you to enroll in **CEA CAPA Secure**. You may call 1.800.266.4441 for details or complete the task in your MyCEACAPA Account. Complete your enrollment online using a credit card, or e-check.

DEADLINE TO ENROLL: **CEA CAPA Secure** must be purchased by the program's Withdrawal Date.

What if I choose not to purchase CEA CAPA Secure?

You may choose not to purchase CEA CAPA Secure.

If you decide not to purchase the plan, you are still eligible under the CEA CAPA Standard Refund Policy, which provides a refund, depending on how close your withdrawal date is to the start of your program. Under the Standard Refund Policy, no refunds are granted after your program withdrawal date and no refunds are possible after the start of your program.
