Who Can Apply?

QUALIFIED APPLICANTS MUST:

- ▶ Be currently enrolled in a degree program in a French institution of higher learning
- ▶ Demonstrate sufficient English language skills (minimum TOEFL score of 520 PBT/190 CBT or equivalent)
- ▶ Be at least 18 years of age
- ▶ Be an EU citizen or have legal temporary residency in France
- ▶ Not be enrolled in a U.S. or Canadian institution of higher education
- ▶ Not be a U.S. or Canadian citizen

- ▶ Receive an official transcript from the University of New Haven, a private, regionally accredited U.S. university*



CEA CAPA reserves the right to select desired participants. All participants will be held accountable for upholding all CEA CAPA rules and regulations. Students will be required to follow relevant sanitary protocols (COVID or other) as they apply at the time of application, orientation, and for the duration of their studies at CEA CAPA. Students are limited to enrollment in one course, to be decided by the CEA CAPA administration and based upon the candidate's expressed preference. Courses meet for a total of 3 hours per week and attendance is mandatory. CEA CAPA selection of retained applicants will be announced late December 2024. CEA CAPA will contact all grant recipients by phone and/or e-mail. Students selected to participate must confirm participation by January 2, 2025 at which time they will be enrolled in the program. Classes will begin the week of January 13, 2025. Students will be expected to participate in a half-day orientation seminar prior to the beginning of the semester. Tuition fees and course activity fees are covered by the grant, but students are expected to purchase textbooks, library cards, and school supplies appropriate and required for the course. This grant is not available to U.S. or Canadian students, or to any student currently enrolled in a U.S. or Canadian university or their overseas study abroad programs. All non-European students must have visas valid for residence in France during the dates of the spring semester. All applicants must be at least 18 years old. / *Official transcripts carry a fee; unofficial grade report available on request at no fee.
